1 Minutes

2 Chair's Annual Report

Martin Soulsby, Chair, welcomed members to the meeting and presented his Annual Report. This was a review of the Association and its activities during 2014. A copy of the text of the Annual Report had been published on the BPA website and a printed copy was on members' seats. A motion to adopt the Chair's Report was proposed and seconded.

3 Subscriptions: 1 April 2015 to 31 March 2016

Debbie Carter, Treasurer, confirmed the figures in the Chair's Report of a 6% decrease in insurance premium^{*} and that Council had recommended no increase in the BPA element, leading to an overall decrease in the annual subscription for a full member of £2.73 from £108.65 in the current membership year to the new subscription rate of £105.92 in the membership year from 1 April 2015 to 31 March 2016. This new subscription rate was proposed and seconded.
