1 Minutes

2 The BPA Skydiving Year 2016

The Chair presented highlights of 2016 and a summary of Council's future strategy. In the membership year to 31 March, there had been a record 6,398 full members.

3 BPA Annual Report & Accounts 2016

The BPA Annual Report & Accounts for the financial year to 30 June had been circulated as an inset to the December 2016 issue of *BPA Skydive the Mag* and posted on the BPA website. Adoption of the report was proposed and seconded.

A motion to confirm the re-appointment of the auditors, Haines Watts, and to authorise the Council to fix their remuneration, was proposed and seconded.

5 Subscriptions: 1 April 2017 to 31 March 2018

Debbie Carter, Treasurer, recommended a full member subscription of £100, comprising a BPA element of £60.61 and an insurance element* of £30.39, a year-on-year reduction of £2.80; and a provisional member subscription of £16.81, comprising a BPA element of £7.01 and an insurance element* of £9.80, a year-on-year reduction of 59p.

The new subscription rate was proposed and seconded.
