03/19 Committee Terms of Reference

With one minor amendment to bullet point 4 under the committee composition the committee were content with the terms as they were presented. One query as to whether there should be the inclusion of the IPC Delegate, as in future this may be a person other than a Vice-President and that the Delegate attends IPC in a competitions capacity, would be researched and the findings presented to the committee. **Action: Committee Secretary**

04/19 Minutes

Minute 69.4 required amendment. After receiving clarification on this point the Chair duly signed the copy as a true record of the minutes of the meeting held on Tuesday 27 November 2018, which had been circulated electronically to the Committee and Council and would be ratified at Council later that evening. 05/19 BPA National in CP 2019 – grievance raised by a member

Item taken from agenda order.

A CP competitor had raised a grievance as to the decision making that led to the BPA CP Nationals being held in Klatovy.

The meeting then moved into a closed session. The Vice-Presidents and COO were invited to stay.

Mikey Lovemore, an employee of and Mike Williams, Tim Gaines, Georgie Vacher and Brian Vacher- all whom jumped at the BPA affiliated DZ who had wished to hold the BPA CP Nationals all declared their interest and would abstain from any vote but were asked to remain for the discussion. As this meant that the meeting was technically non-quorate any decision would be recommended to Council at its meeting held later that evening.

After due discussion the committee agreed that whilst the Nationals should be held in the UK no bid had been received. The discussion and decision had been based on the information presented at the time by 2 interested parties. The committee therefore would recommend to Council that the decision be upheld. **Recommend to Council**

The CP Rep would discuss with the affiliated DZ in bringing their pond to a standard set by IPC. **Action: CP Rep**

06/19 Matters arising

Out of agenda order.

6.1 Reimbursement from sponsored team

The committee noted that the majority of the sponsorship allocation had been repaid.

However, it was calculated that £270 each was still outstanding. After discussion the FS Rep proposed that the outstanding sum of £540 be repaid by the end of the membership year – 31 March 2019. Seconded by Ian Marshall. This would be reported to Council with a recommendation that Tony Butler relay this decision to the team.

7.1 Sponsorship Allocations

7.5 BPA Meet issues – taken from agenda order

The Senior accuracy team had notified the Classics Rep of a clash between an event in Lodi, California which they wished to use towards training for the FCE, and the BPA GP in Accuracy to be held at Peterlee. Following due discussion those present could see no valid reason for the GP Accuracy dates to be changed.

Sponsored athletes leave the meeting at the Chairs request.

7.6 Continuation of minute 7.1 – Sponsorship Allocation

The FS Rep proposed that the sponsorship allocations, as circulated in December 2018, be presented to Council. Seconded by Classics Rep.

7.7 Accuracy sponsorship

After consideration to the circulated request the Classics Rep proposed sponsorship be used to reimburse costs of parascending lifts, which are a cheaper alternative to flying our athletes to altitude. Seconded by CF Rep.

9/19 FAI IPC Annual Plenary Meeting 2019, 26-27 January 2019 – Delegate report

The IPC delegate highlighted a few of the many points from his report:

- Date of IPC Plenary clashes with date of BPA AGM
- Rules were due to be published
- In order to encourage female participation, there were now dedicated slots for females at FCEs
- Mondial - Russia 2020

Those present thanked the Delegate for his detailed report.

10/19 BPA Competitions 2019 – continuation of min 8

10.1 BPA National in CP, 14-18 Aug, Klatovy, Czech Rep

A trainee and a returning judge were required to judge a Nationals in order to obtain their National Judge rating in CP. As the Meet was outside of the UK the Judges Coordinator proposed that their costs of food, accommodation and travel, capped at no more than £500

per person, with a maximum of 2 people, be refunded, on completion of the course.
Seconded by the CF Rep.

Carried unanimously

10.2 RAeC Queens Cup Air Race 2019

The committee were informed that Skydive Hibaldstow had been successful in their bid to host the RAeC Queens Cup, at the BPA National in FS 4-way to be held on 24-27 August.

10.3 BPA National in WS Performance & Acrobatics

After due discussion of the pre-circulated proposal by the WS Rep which requested the addition of a Tracking Suit category at the WS Nationals, the FS Rep proposed, and was seconded by Sam Lee, that the WS Rep draft and present the rules to the judges for their consideration, before the rules could be circulated to the committee for possible approval at its meeting in April.

Carried, Action: WS Rep

10.4 UKSL Meet 3, Skydive Buzz

To increase exposure of VFS to competitors and judges alike the VFS Rep proposed a 6-round trial of 4-way VFS as a side event to the UKSL. Seconded by the Judges Coordinator.

Carried unanimously

11/19 Judging Matters

11.1 Judges attending BPA Meets

The Judges Coordinator reported that all Meets were covered with the exceptions of WS Nationals and CF Nationals, where overseas judges were potentially required to cover the shortfall. She highlighted that the FS Nationals judging equipment needs were typically supported by the hosting DZ. It was recommended that the Judges Coordinator explore the possibility of one of the tech support team members judging FS at no cost to the BPA.

Action: Judges Coordinator

11.2 Judges Training Seminar

The Coordinator confirmed that the seminar would take place on 23-24 March at BPA HQ.

11.3 Trainee Judge membership

The Judges Coordinator proposed that the trainee judge attending the seminar would not be required to hold full BPA membership, as there was only 8 days left of the membership year. Seconded by the WS Rep.

Carried unanimously

11.4 Judging equipment

11.4.1 Texair contract

Andy Houston of Texair had informed the committee that the contract to maintain, transport and run the equipment at an event concluded in 2020, after which, whilst content to supply and maintain the equipment, he would no longer attend the event for the duration. After due discussion the Chair asked the Classics Rep to put together a specification of what was required for a tender document to be produced, for which Texair would be invited to tender.

Action: Classics Rep

The Committee thanked Andy for his commitment and dedication to BPA competitions.

11.4.2 Judges laptops

The Judges Coordinator proposed an additional laptop to the same specifications at the same approximate cost and was seconded by the WS Rep. The committee were content with the quote of £1,174 for a laptop with all the necessary specifications, as provided by the ITWG Chair.

11.5 Proposed judges to FCEs in WS and Speed

The Competitions and Judges Coordinators confirmed that the Proposed Judges form had been completed and returned well before the 1st March deadline.

12/19 International Competitions 2019

12.1 4th FAI World Cup, 3rd European Championship of Speed Skydiving, 13-15 Aug, Skydive Buzz, Dunkeswell, UK

Those present congratulated Mikey Lovemore on his successful bid and presentation at IPC, for Skydive Buzz to host the FCE.

The Speed Rep noted that changes at IPC level with regard to female categories, in which for

Speed discipline 2 of the 12 places available to delegations were allocated to female only, might have a possible effect on BPA Nationals rules.

A call for a Head of Delegation was required.

Action: Secretary

The Speed Rep would inform the Competitions Coordinator of the athletes to invite.

The meeting then moved in-camera. Committee members that had made applications left the Meeting as their event was due to be discussed.

12.2 14th FAI World Cup of Freefall Style & Accuracy Landing, 19-25 May, Cordoba, Argentina

It was proposed by the FS Rep, seconded by the WS Rep, that Ian Marshall attend as Head of Delegation.

12.3 10th FAI World Cup, 8th European Championships in CF, 17-20 Aug, Strinic, Romania
