21/16 Matter arising from the minutes

21.1 Competitions Coordinator

The Committee warmly welcomed Meghan Sheedy to the fold and looked forward to working with her.

22/16 BPA Judges Procedures

Tash Higman reported that feedback was more positive once people were made aware of the purpose of the document, and had received a number of notes from judges and Committee which she would collate in a redraft of the document. Tash proposed that she progress the document for review by Competitions Committee at its October meeting. Seconded by Mike Lewis. <u>Carried unanimously</u>

23/16 Domestic competition rules 2016

The BPA Office made the Committee aware that due to some of the rules being returned to the office too late for circulation to the hosting centres, that the rules could be approved subject to DZ confirmation, unless otherwise stated below.

23.1.1 Accuracy

<u>Nationals</u>: Tash Higman proposed, seconded by Ian Marshall that the Accuracy Nationals rules be approved. <u>Grand Prix</u>: There was a slight typographical error on the title. Tash Higman proposed, subject to typo edit, that the rules be accepted. <u>Carried unanimously</u>

23.1.2 Canopy Piloting

<u>Nationals</u>: The CP Discipline Rep had confirmed with the host that the admin section of the rules were correct. The Committee recognised that a few amendments were required regarding the 'carve' and Sporting Licence requirement. Brian Vacher proposed, and was seconded by Mike Lewis, that with the amendments the rules be approved.

Carried unanimously

<u>Grand Prix</u>: The CP Discipline Rep required clarity as to whether the event would be a Grand Prix or a private event therefore no rules were available at this time.

23.1.3 Speed

<u>Nationals</u>: With the removal of the Junior category and wording specific to that category, and Sporting Licence requirement Ian Marshall proposed, seconded by Tash Higman, that the amended draft be accepted. <u>Carried unanimously</u>

23.1.4 Canopy Formation

<u>Nationals</u>: The CF Discipline Rep confirmed that the DZ had agreed the admin section. Tash Higman, seconded by Ian Marshall, proposed that these rules be accepted.

Carried unanimously

<u>Grand Prix</u>: The were no major changes. Therefore, Tash Higman, seconded by Ian Marshall proposed the rules be accepted.

23.1.5 Artistics

<u>Nationals</u>: With minor amendments Tash Higman proposed, seconded by Gavin McLeod, that the rules be approved. <u>Carried unanimously</u>

23.1.6 VFS

<u>Nationals – 4-way VFS</u>: With minor changes Mike Lewis proposed and was seconded by Tash Higman, that the rules be accepted. <u>Grand Prix – 2-way VFS</u>: Tash Higman, seconded by Ian Marshall, proposed that the rules be accepted. <u>Carried unanimously</u>

23.1.7 Formation Skydiving

The FS Discipline Rep explained that due to work commitments he had been unable to focus time on amending the FS rules for 2016 but had a view to circulating to the Committee by email by Friday 22 April. The Chair asked that if there were difficulties meeting this deadline that he considers delegating.

23.1.8 Entry Form

Mike Lewis proposed, seconded by Gavin McLeod, that the Entry Form be accepted.

Carried unanimously

23.1.9 Wingsuit

The Wingsuit rules had not been received and there was no mention of them.

24/16 Election of Judges Coordinator

Taken from agenda order on the arrival of Jason Kelleher.

Jason Kelleher proposed, seconded by Gavin McLeod, that Kate Charters be elected as Judges Coordinator. The vote was For: 3 Against: 1 Abstain: 1 <u>Carried</u>

25/16 Domestic Competitions 2016

25.1 <u>BPA British Open Nationals in Wingsuit Performance & Acrobatics, 27-30 May,</u> <u>APA Netheravon</u>

25.1.1 Team selection for FCE Wingsuit Acrobatics, Zephyrhills, Florida

The Committee noted a request received from the WS Discipline Rep that put forward 2 teams that had qualified at the 2015 BPA British Open Nationals, and requested that the 2016 BPA British Open Nationals be considered as a selection event for 2 further teams to attend the 2016 FCE in Zephyrhills. After due discussion Tash Higman proposed, and was seconded by Ian Marshall, that only teams from the 2015 Nationals are selected, as per the rules set in the funding document.

Carried unanimously

25.1.2 <u>Request to fund Paralog equipment and Judge</u>

A request to assist with funding the specialist judge and equipment, and a copy of the Paralog PPC Licence and Flysight Loaner Agreement had been circulated to the Committee with the agenda. After due consideration Ian Marshall proposed to fund the Paralog equipment and Judge up to £1500, if funds were available. Seconded by Mike Lewis.

25.2 Any domestic competition issues

25.2.1 <u>Safety at Nationals</u> – deferred from Feb 16 meeting The Committee supported teams that wished to stand down if they believed that conditions were not favourable for the team to complete the jump safely, but recognised that further information was required from the hosting PTO as to the logistics of calling the event after 2 days. The Chair would discuss the matter with the Simon Donnelly. <u>Action: Chair</u>

25.2.2 BPA British Open Nationals in CF 2016

To formally record date change to 5 – 7 August 2016.

26/16 International Competitions 2016

26.1 <u>6th FAI World Canopy Piloting Championships, 20-27 Aug, Farnham, Canada</u> The bulletin had not yet been released.

The Committee acknowledged that a CV had been received, but requested that the role be made known publically through the Minutes and through the social media platforms available. <u>Action: BPA Office</u>

26.3.2 Delegation Uniform

Jason Kelleher proposed that as this year it would be a BPA delegation, that the delegation be given the full BPA uniform. Seconded by Tash Higman.

As these disciplines were not contested no selections could be made in Solo Freestyle, 4-way Dynamic, 4-way VFS. The Rep requested that other events, such as BPA Artistics Nationals, be taken into consideration. The Rep had also provided a list of teams eligible, from the same selection event:

26.4.1 Head of Delegation

Tash Higman and Mike Lewis declared an interest as jumpers at Netheravon. However, the Chair believed that this would not be an issue for this item. 1 CV had been received, from Mark Bayada. After due consideration Jason Kelleher proposed, and was seconded by Mike Lewis, that Mark Bayada act as Head of Delegation. Carried unanimously

26.4.2 Competitor change & funding allocation

The Wingsuit Discipline Rep informed the Committee, by email, that Joseph Likerman was now unable to compete, and asked that Al Bradie take his place and that the agreed funding allocation for Joseph be brought down to Al. Mike Lewis proposed that Al Bradie take the place of Joseph Likerman and that the entry fee element of the funding of £650, be passed down to AI, without the training element.

Judges attending International events have been listed under the appropriate competitions. The Committee congratulated those chosen to judge at International events and were proud to have such a representation. They then thanked Tash Higman for providing the list and updates.

27/16 Competitions Action Plan & Budget: 1 July 2015 to 30 June 2016

Weed reported on various aspects of the budget and plan, and was pleased to report that all outstanding remittances to the British Team Fund had been received.

Equipment & Judges costs for 2014 & 2015 – Skydive Buzz Ltd 27.1

The Committee noted that reasonable costs for equipment to the 2014 Nationals had been agreed at its meeting in February 2013, but no such provision had been made for 2015 and that no request had been received from Skydive Buzz to cover equipment for 2015 Nationals prior to the invoice being sent. It was not clear if the judges' costs, were for the 3 2015 Grand Prix, or for the Nationals which, as per the bid form held 'at no cost to the BPA'. Mike Lewis proposed that the judges meals element needs removal from the invoice, that documentation for equipment used at 2015 Nationals was required and a budget for 2016 Nationals be produced before sending an invoice, should they be looking to request assistance from the Committee. Seconded by Tash Higman.
