#### 62/16 Resignation of Mike Lewis

The Committee were saddened to note the standing down of Mike Lewis due to work commitments but thanked him for his valuable contributions to the BPA Council and Competitions Committee. All wished him well for the future.

#### 63/16 Declaration of Interest

#### 64/16 Competitions Committee Terms of Reference

As the Council composition was changing it was recognised that these changes may also affect subcommittees so would review once these changes were known.

#### 66/16 International Competitions 2016 – yet to be completed

#### 66.1 2<sup>nd</sup> FAI World Cup of Indoor Skydiving, 11-16 Oct, Warsaw, Poland

The Competitions Coordinator reported the unfortunate news that Satori, a FS 4-way Open team had since withdrawn. Weed Stoodley, team member for the 4-way VFS team apologised and reported that due to health reasons her team would also be withdrawing. The Coordinator would enquire as to a refund of the team's entry fees. The Committee wished Weed a speedy recovery. The Coordinator went on to add that now 7 teams and 1 solo competitor would be attending, and all including the Head of Delegation had registered.

# 66.2 <u>1st FAI World Wingsuit Performance Championships & 1st World Cup of Wingsuit Acrobatic, 2-11 Nov, Zephyrhills, Florida</u>

A full delegation of 8 competitors and 1 Acrobatic team would be attending. The Competitions Coordinator reported that Al Bradie had since withdrawn, but had been replaced by Mike Williams.

#### 67/16 BPA Skills Coaching Roadshows

The Committee Secretary, on comments regarding the draft Roadshow request forms, asked that the Committee email her of any changes in order that the draft be amended before circulation to Committee for approval, then on to Dropzone Operators and Chief Instructors for completion.

The Vice-Chair then relinquished the Chair to Brian Vacher.

**Matter arising from the minutes** – not covered elsewhere on the agenda There were no matters arising.

#### 69/16 Team Euphoria Appeal

Sean Freeman, of Team Euphoria, spoke to his paper circulated with the agenda. The meeting then moved in-camera with all but voting members leaving. Jason Kelleher declared his interest as a team member whose team had been allocated funds however the Chair invited him to remain.

The Committee recognised that there was an element of subjectivity which was necessary to allocate funding with the information the teams had supplied in 2015, and to hone the criteria for future requests. However, to allocate further funding after the initial allocation in 2015 may set a precedence for future requests. Jason Kelleher proposed that the Committee had followed due process in all aspects. as understood prior to the funding allocations in 2015, on the information the Committee had at the time. However, the process will be reviewed. Seconded by Gavin McLeod. The vote was: For – 4, Against – 0, 1 abstention – Jason Kelleher.

Sean Freeman only was invited back into the meeting. Sean expressed his disappointment towards the decision from himself and on behalf of the team, but that he was aware of the other factors and asked that the Committee be aware of teams that are close in points that may need to be considered equally.

#### 70/16 2017 BPA events

#### 70.1 APA Armed Forces Parachute Championships 2017

The Committee acknowledged an email circulated with the agenda from Jackie Harper regarding the APA Armed Forces Parachute Championships whose dates for 2017 were likely to overlap with BPA National Championships in FS, Artistics and Speed. The Committee were aware that the BPA were under no obligation to provide judges but would endeavour to ensure judges are available to cover their competition, and asked that the Committee Secretary request of APA to review their dates, or if not possible to run their FS competition from the Tuesday to the Thursday of that week as it would allow both judges and competitors to travel and attend both events, and to inform APA that it was the intention of BPA to continue to run BPA Nationals in FS within that time period in future years and ask that this be taken into account.

# 74.1 <u>BPA National Championships in Artistics, FS 4-way and VFS, Target Skysports, 20-22 Aug & reserve 27-29 Aug 2017 & BPA National Championships in FS 8-way, Artistics and Speed, 27-29 Aug 2017</u>

The Chief Judges report, which was taken as read, reported 60 registered 4-way FS teams, 4 VFS teams and 12 Speed competitors. Both event dates were unfortunately beset with inclement weather hence the rollover to the reserve weekend for the FS 4-way. The Committee echoed the Chief Judge in her thanks to Ron Mia Snikov, who on one of the many weather holds had hosted an open forum for the Artistics, to Noel Purcell as Meet Director and the many Hibaldstow staff and to the Judges and Csaba Sorenzi.

#### 74.1.1 Issues arising

The Committee queried whether a team should have to pay for a rejump should they had been manifested, called and boarded the plane but due bad weather, had not jumped. It was known that should a team refuse to board the aircraft; they would score a zero. The consensus of the meeting was that a team should not have to pay for the rejump, but as there was no clarity within the rules this would be reviewed for the next 3-year competition cycle which may also include a change to the competition bid form. Confirmation of rejump fees, if any, in the event of a team whilst onboard the aircraft, not jumping due to bad weather conditions. would also be sought from Target Skysports with regard to the competition in 2017.

#### 74.1.2 **Speed**

The Speed Discipline Rep reported that he felt that it was unethical that whilst a competitor at the Meet he was having to fend queries from the Judges and the Meet Director, but recognised that it appeared that the Meet Director had too much to do rather than keeping to his role of Meet Director and that an extra judge may have been required. There were also issues with the Speed scores, as these were not displayed until he had retrieved them from the ISSA website. The consensus was that these Judges must make the scores available even if this required the whiteboard system as used previously for other disciplines.

#### 74.2 BPA National Championship in Accuracy, Skydive Swansea, 26-29 Aug 2017

The Judges Coordinator reported that there had been an increased number of intermediates and that it had been a good competition with a new British team record set (as yet unconfirmed).

#### 74.3 BPA National Championship in Speed 8, UK Para Sibson, 17-18 Sep 2017

Richie Del-Toro, speaking to his report circulated with the agenda, reported that 9 teams had completed 4 rounds but the competition had unfortunately been called due to bad weather.

#### 75/16 International Competitions 2016 – completed

75.1 6<sup>th</sup> FAI World Canopy Piloting Championships, 20-27 Aug, Farnham, Canada
The Committee thanked John Smyth for his report, and were pleased to note that the entry fees for those who had been unable to attend had been recovered. It was unfortunate that wind conditions had meant that only 1 round of Speed and 1 round of Accuracy had taken place, and that Distance did not have the chance to finish 1 round. Despite difficult conditions Team GB did their best.

#### 75.2 2016 FAI World Parachuting Championships – Mondial, 11-20 Sep, Chicago

The Committee thanked John Smyth and Ian Marshall for their reports, and noted correspondence received from Pete Sizer, Emma Hart of Revolution Freestyle and Anna Hicks of NFTO, and Mike Lovemore. The Committee were extremely proud of the delegation, and of NFTO (Anna Hicks, Ane Bauerle-Brentford, Maria Russell, Vana Parker and Simon Brentford) who had won Bronze in FS 4-way Womens, and Max Hurd who had won Bronze in Speed. The Committee echoed the thanks from Pete Sizer to Meghan Sheedy, Competitions Coordinator, for all her hard work in the preparation

# 77/16 <u>Competitions Action Plan & Budget: 1 July 2015 to 30 June 2016 and 1 July 2016 to 30 June 2017</u>

The Committee noted the correspondence circulated with the agenda and questioned whether the tuffet had been collected from Sibson and if the fan and generator were included with it. The Chair would enquire of Texair as to the location of the fan and generator, and may reduce the price for all 3 items to £900 exclusive of VAT, and would report at the next meeting.

The Chair suggested a meeting between the Judges and the Committee. The Committee also recommended a Certificate of Merit for NFTO on their achievement of winning Bronze at Mondial. After much discussion that NFTO and Mike Lovemore had both received RAeC awards Ian Marshall proposed, and was seconded by Jason Kelleher, that Max Hurd receive a Certificate of Merit.
